

Asurion Tablet Computer Giveaway Sweepstakes (“Sweepstakes”) OFFICIAL RULES

The Asurion Tablet Computer Giveaway Sweepstakes (the “Sweepstakes”) begins at 10:00 a.m. CST on August 3, 2020 (the “Sweepstakes Start Date”) and ends at 2:00 p.m. CST August 14, 2020 (the “Sweepstakes End Date”), (such period referred to herein as the “Sweepstakes Period”). The Sweepstakes is sponsored by Asurion Services, LLC (the “Sweepstakes Sponsor”).

1. HOW TO ENTER:

- To be an eligible entry, participants comment on the announcement post on Instagram. Asurion will randomly choose from all eligible submissions.
 - Like this post
 - Follow @Asurion
 - Tag @a friend
 - Each additional comment @an additional user counts as an additional submission
 - There is no limit to the number of submissions; however, user is only eligible to win one time during the course of the Sweepstakes Period.

- To enter by mail, print your first and last name, complete address, city, state, zip code, daytime telephone number, date of birth, and e-mail address (if available) on a three-by-five-inch card. Put the card in an envelope, affix first-class postage, and send it to the Sweepstakes Sponsor with attention to Asurion, Tablet Computer Giveaway, 648 Grassmere Park, Suite 300, Nashville, TN 37211. No illegible, incomplete, forged or altered entries will be accepted.

- Asurion will then announce the winner by reaching out to the user through direct message or contact the phone number that was provided in the mail in entry form.

- **Description of Requirements**
 - Participation posts must include @a friend and remain visible to Asurion on Instagram throughout the duration of the Sweepstakes and until awarding of the prize, otherwise, specific entry is not considered
 - Participation and finalist posts are considered as participant agreeing to official rules
 - Must not contain anything obscene, offensive or any language or imagery that’s inconsistent with the positive images Asurion wants to associate with
 - Entry must address and respond to Sweepstakes post prompt
